## 2. Provider Spotlight

- a. United Services InSHAPE: wellness initiative that supports weight-loss and dieting goals. Many of the InSHAPE participants are also BHH clients.
  - i. Certified Personal Trainer required for fitness aspect of the program
  - ii. Both 1-on-1 and group sessions available
  - iii. Clients set wellness goals that are monitored and supported over the course of three months
  - Collectively, Willimantic InSHAPE participants have lost 377.2 lbs and Putnam/Danielson lost 144 lbs
  - v. Smoking Cessation is also a huge part of the initiative.

# 4. Integrated Practice Assessment Tool-IPAT

- a. Participants reviewed results of IPAT assessment. Information will be used to map agencies' locations and indicate the range of integration levels across BHH. If a provider believes the level indicated on the handout is incorrect, contact Denise at 860-704-6148.
- b. Discussed the process of completing the IPATs, feedback on what the providers thought about it, and the responses of staff helping to complete the tool.
- c. Reviewed tables from "A Review and Proposed Standard Framework for Levels of Integrated Care" related to cores descriptions of the six levels of collaboration/integration, key differentiators of the various levels, and the advantages and weaknesses of each level.
- d. Q&A related to "pain points" and challenges with having towards more integrated care:
  - i. System/Data sharing challenges

- ii. Documentation is the hardest part. BH and medical notes and documentation very different
- iii. Having "more gods to answer to" around requirements, directions, etc.
- 5. Providers feel it would be helpful to have a list of providers and descriptions of their integration characteristics (level of integration, primary care on or off site, and primary care consultant specifics). ABH to create and send out.

#### 6. Data Discussions & Timelines

- a. ProviderConnect procedures Providers should submit ProviderConnect access forms directly to Beacon using the email or fax number on the form. Anyone who requires access to Beacon reports should attempt to gain access to ProviderConnect. Reports should be available on ProviderConnect by Summer.
- b. Tableau/Citrix procedures The first round of Tableau/Citrix access forms have been submitted. If anyone's name who should have access is not on the list of forms received, contact Denise at droberts@abhct.com. Beacon is currently working to process forms and send access information to providers.
  - Attendees received a document explaining the differences between the Tableau/Citrix and ProviderConnect access forms. If providers need additional copies of this document, email Denise at droberts@abhct.com.
- c. State-operated health assessments
  - i. A list of clients with health assessment errors will be added to Tumbleweed for providers to review. Denise will be calling each one individually to make corrections.
     Providers will not have to resubmit health assessment, but should be prepared to provide any missing information.
  - ii. Discussed tobacco cessation question and uncertainties or differences in understanding of response options. Reviewed how some providers are collecting the HA information.
