## 1. DMHAS, ASO, and Provider Updates

- a. DMHAS Training Opportunity with PIC-CT Grantees

### b. Billing Updates

- i. FY19 PC Consultant trackers
  - Year-end totals sent on recent report cards
  - If an agency feels there is an error with the totals, let Lauren know
  - There have been changes to the Client Summary Report
    - Service location and total service duration added
    - Service location will help with waiver clients in Psycho-Ed in office
    - Providers should be doing quarterly reconciliations to assure numbers are correct
  - Discussed potential changes to billing for case management with collateral and phone services for clients under 21
    - POST MEETING UPDATE: After additional research, there will be no changes to current BHH billing. DMHAS will not bill for these services and they will remain on the BHH Missing Data report.

  - ix. Client name
  - x. DOB
  - xi. Hospital visited or admitted to
  - xii. Discharge date
  - xiii. If readmitted in less than 30 days
  - xiv. Admissions per month?
  - xv. Average stay
